- Currently commissioned and assigned as an HCSO Reserve Deputy and have completed no less than 1,040 hours in a law enforcement First Responder position with the HCSO Reserve Command
- Valid Texas Driver's License Texas
- Eyesight must be correctable to 20/20 vision, normal color, and peripheral vision
- Correctable normal audible range in both ears
- Must successfully pass the physical abilities test battery (PAT):
  - Obstacle Course (New)
- Firearm's qualification
